Matt Bayne, Finished Concrete gave the board an update on sidewalk project, prices have increased from their suppliers which of course gets transferred to us. MDOT is continually changing their requirements and the weather always plays a roll. This year's plan is to finish the West & East side North of the intersection totaling \$143,658.88 an approximate \$10k will be deducted for dumping. Rob stated that anything that doesn't get completed will cost the township more for the reasons stated above so it's very important that this phase gets completed.

T.J. Thomas and Sons approached the board to let us know they will no longer operate or manage the Comins Twp. Transfer Site and that subcontractor Spencer Weaver will operate by the original agreement made 12-23-2020 for the next 30-60 days, this will allow the board to reach out to the community for request for proposals (RFP) Comins Twp. board expressed their appreciation to the Danhoff family for their efforts to carry out the agreement knowing that the passing of their father Dewy as made it a challenge in many ways.
