Approval of Minutes [July 13th, 2023] – Arisa Handrich 1rst John McConnell 2nd, All in favor

Guest: Rob Murphy, Twsp Supervisor, invited to join

Public Comment: no 'new' public comment not related to discussion items

New Business:

Special Meeting To Discuss whether ordinance to opt out of marijuana dispensaries should be changed to allow dispensaries

Rob Murphy advertised this public comment meeting thoroughly and we had a record attendance by the public

Old Business: a] Canna Club review – Public in attendance numbered 27 people, 22 people signed in. As polled by 'hands up' 25 people were against changing the ordinance to allow a dispensary, 2 people were for changing the ordinance to allow a dispensary.

Roman Benson spoke about his request to allow his planned dispensary, outlining his operating plans, how his current site in Big Creek Twsp has been welcomed by neighbors – citing how there were no needed visits by law enforcement – how they run the business according to current state laws and regulations, how they try to be a welcomed, legal business in the community.

'FOR' changing the ordinance

Under public comment of people 'for' changing the ordinance, two [2] people voiced opinions. **Julie Stewart** commented that she was for a new dispensary, stating that she know many people are wanting one in our township, but that most were afraid to come and publicly voice their opinions as they feared speaking about same in our conservative group.

Dani Yustick agreed with Julie, and stated that she would rather see people get their marijuana from a regulated dispensary instead of from 'street sales'.

'AGAINST' CHANGING THE ORDINANCE

Lowell Eastman – stated that he believed the added revenue from a dispensary wasn't needed in our community from a business like a dispensary

Herb Montague stated that he thought that such a business doesn't fit the 'family' atmosphere of Fairviewour small community feeling

Virgil and Ruth Hershberger expressed their opinion that such a business doesn't fit our local area, and that the same products are available nearby in other townships

Robert Jones doesn't want a business like Canna Club, or any other dispensaries in our community and that the current ordinance to 'opt out' of allowing such already stands and doesn't need to be changed

Many other residents expressed the same views, not wanting marijuana dispensaries in our community

Call ins

Rob Murphy stated that he received an email [which he shared] from a woman in opposition to changing the ordinance; and Rob shared that he had four phone call ins expressing opposition – no call ins 'wanting' the ordinance to be changed

Planning Commission opinions

Dan Swartzendruber asked the opinions of commission members on whether to ordinance opting out of dispensaries should be changed

Kyle Yoder said that he was strongly pro business but that he would probably be neutral in his opinion if it came to a vote in November, but that he didn't think the ordinance needed to be changed since there was so much opposition to same evident at the meeting. So he was against changing the ordinance.

Arisa Handrich opined that the ordinance shouldn't be changed

John McConnell said he felt that the ordinance should stand as is since there was no apparent benefit to adding a dispensary

Jerry Kunnath decided, after much heehawing back and forth and numerous questions/discussion, that he was against changing the ordinance

Dan Swartzendruber said that he knows, after much discussion with citizens over the past few months, that many people in the community aren't in favor of the ordinance being changed, and that these same people voted for the ordinance; so he was not in favor of changing the ordinance either.
