Perry Lake Milfoil: Mike Smith reported that he has been working in the North channel and it appears that they are not able to keep up with the Milfoil, he also mentioned that chemical treatment and DASH would work well together. Fred Denman added that Dr. Jones would guide us as to what chemicals are safe to use, her cost for assessing the lake is \$7k.
