- 7. You agree to vacate the premises at the scheduled time.
- 8. No personal property shall be on the premises other than during the rental period. If any personal property is left at the Township Hall in excess of 48 hours, it shall be considered abandoned, and the Township may dispose of the personal property in its discretion.
- 9. You agree to return all Township property to designated storage spaces.
- 10. No animals are permitted in the hall except for service animals.
- 11. The individual or entity renting the Town Hall must be the one using the Hall. A Township resident cannot rent the hall for a non-resident at the rate charged to residents.
- 12. The hall will be opened by 8am. If you need it opened earlier, please note it above.

- 3. Acknowledgment:

You and all members of your party are required to acknowledge your receipt of these rules. Your acknowledgment of the receipt of these rules, shall constitute your agreement to these rules as well as your acknowledgment that there are risks of COVID-19 infection posed by having indoor gatherings, coming into contact with others at the Township Hall, and utilization of the Township Hall's facilities.

FURTHER, YOU AGREE TO HOLD HARMLESS, DEFEND, AND INDEMNIFY THE TOWNSHIP, ITS OFFICERS, AGENTS AND EMPLOYEES FROM ANY AND ALL CLAIMS THAT MAY BE BROUGHT BY ANY OF YOUR VISITOR(S) OR GUESTS AT THE TOWNSHIP HALL AS A RESULT OF COVID-19 AND WHICH ARISE OUT OF THE GUEST OR VISITOR'S USE OF THE TOWNSHIP HALL.**
